Re: Updates for Parks, Recreation and Cemetery Department

As we transition into fall we will begin to winterize shelters and prepare for ice rinks, snow removal, cross country ski trails, and additional winter recreational opportunities and programs. We will also be working to complete two additional projects before winter.

On Monday, September 12, 2016 we will be working with Rotary and members of the Antigo Disc Golf League to place the new disc golf baskets for the additional 9 holes that expand our course to 18 holes. We are excited to offer our community an expanded course and hope that we will see some tournament and expanded league play as a result. We are grateful to Rotary for funding the expansion and the Disc Golf League for their efforts to work on work brush clearing and course clean-up prior to the work day.

We will be working with Antigo Area Youth Hockey Association to move the First Avenue Hockey Rink Boards south of the Peaceful Valley Warming House, so we can hopefully see an increase in activity and use of the hockey rink due to the proximity to the Warming House and restrooms.

Staff has done an excellent job of maintaining the cemeteries, parks, and facilities this year while also coordinating a busy summer of activities and programs. Julie has been keeping up with various community events and programs ensuring that the Community Calendar is up-to-date as well as our Park & Recreation Facebook page (see the attached sheet for a list of events and upcoming programs and activities). Doug Curler with the Senior Center for Langlade County has been keeping us updated with their programming and activities that we post on the calendar and on our website.

We will be working with Economic Development and the Antigo/Langlade County Chamber of Commerce to notify the public of park, trail, and program updates through Everbridge (the Community Alert System). Re: Remington Lake Dock Ramp Extension

When the specs were originally drafted for the dock we had a relatively typical year for rainfall. However, this past year we have had quite a bit of rain and water levels have been considerably higher than we could anticipate. As a result of the higher water levels the original ramp length of 3' creates a very steep incline to access the dock or shore. We contacted Dvorak's Docks and they can credit us for the original 3' ramp and install a new 5' ramp for a difference in cost of \$837.00. The increased length will create a smoother transition and reduce the slope. I am requesting permission to use the budgeted CIP funds allocated for the dock. The original bid price came in under budget, so we have funds available to accommodate the longer ramp.

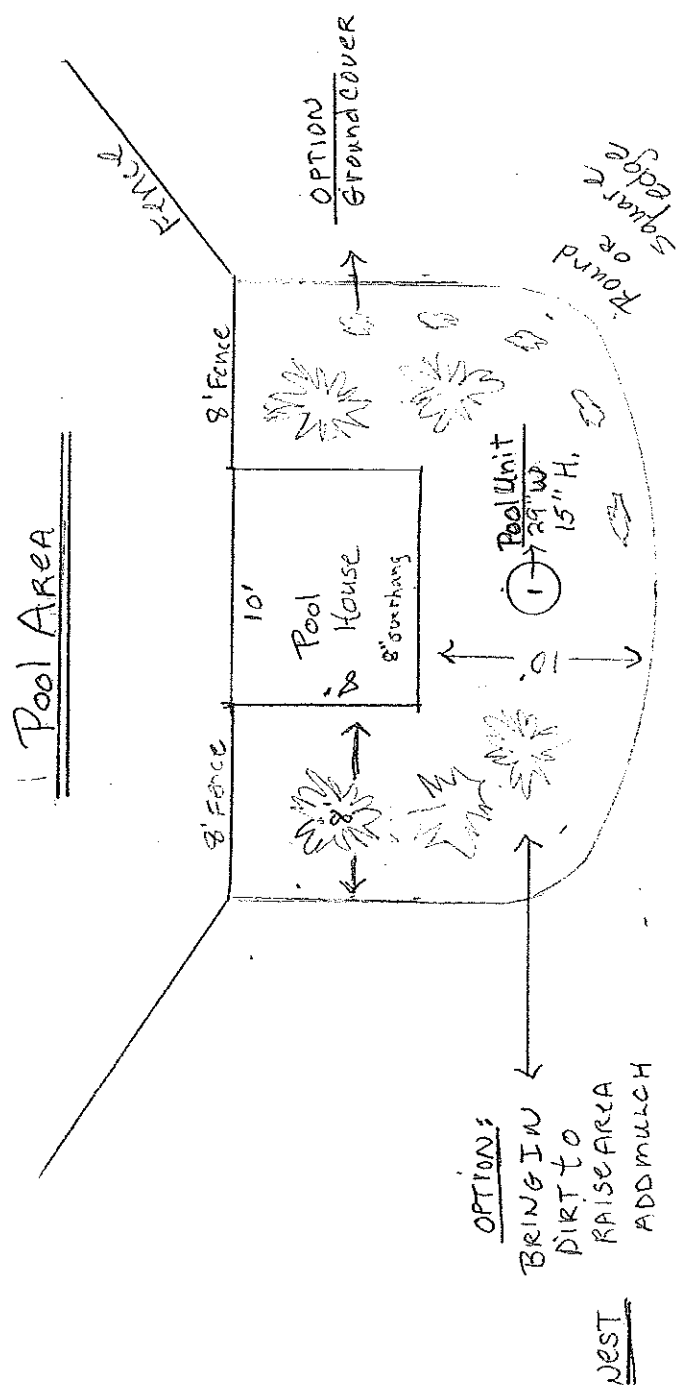

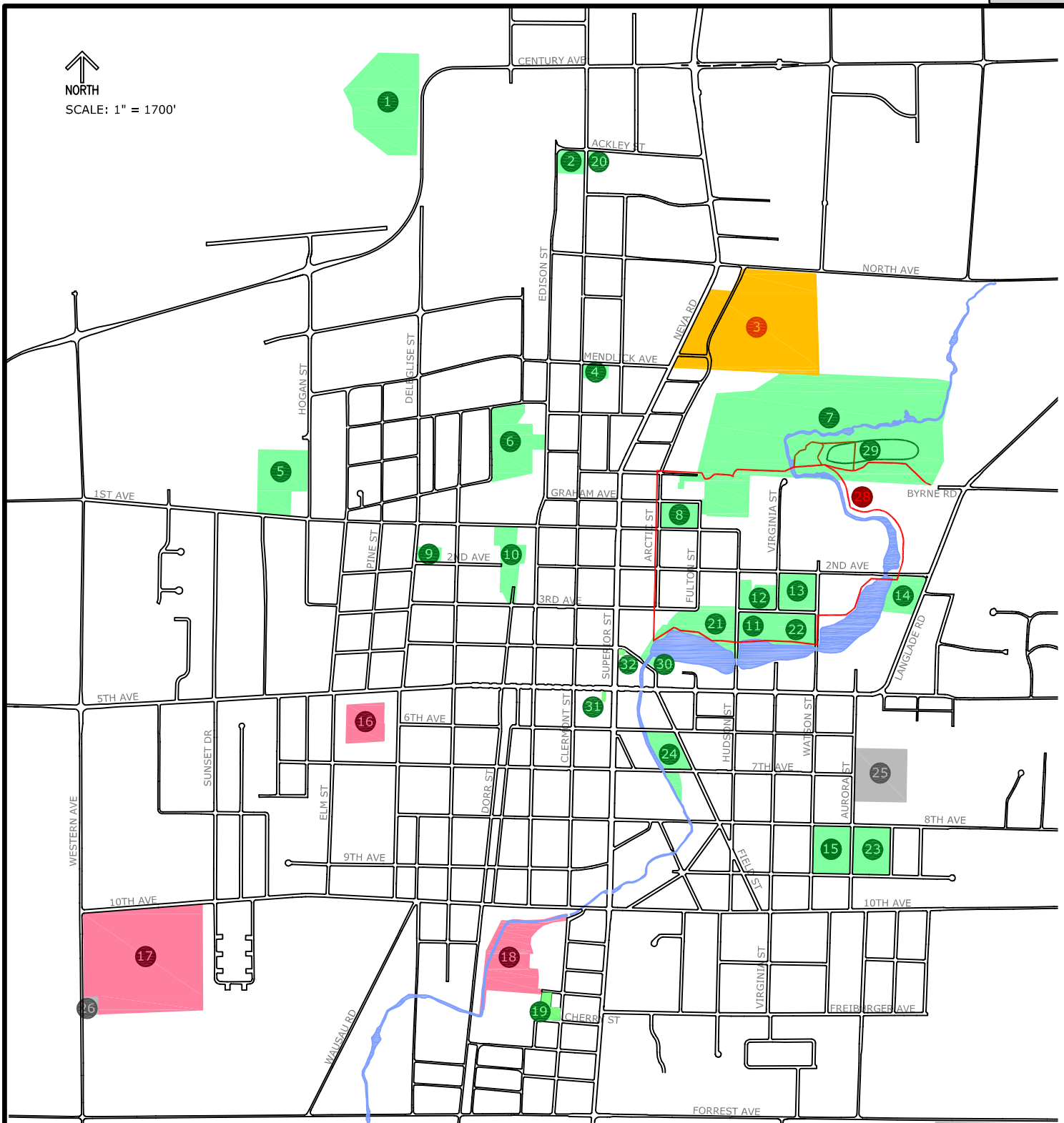
