As some of you may know, Lt. Mark McKinney has retired from the City of Antigo Fire Department which creates a vacancy for a new Fire Fighter. Lt. McKinney's retirement also opens up a Fire Lieutenant's position within the fire department.

After posting the open Lieutenants position per the union contract, I received seven applications. I was able to rank the seven candidates on three categories; (1) survey by department personnel on their Work History, Personal Development & Leadership Skills, (2) the letter of interest submitted by each candidate and (3) the candidate's education.

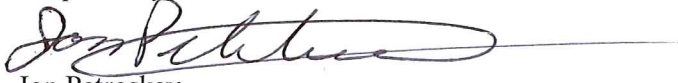
After the above process was completed, Corey Smith received the highest ranking and I am recommending Corey for the promotion of Fire Lieutenant. Corey started with the Antigo Fire Department on August 2, 2004 and has been filling in as an Acting Lieutenant since May 30, 2015 when the Lieutenant is off during vacations or at trainings.

I firmly believe Corey has the skills and ability to successfully fill the position and support my decisions as a Fire Lieutenant. I am requesting your approval to appoint FF Corey Smith to Fire Lieutenant effective January 3, 2021.

As for the open Fire Fighter position, I am requesting approval to hire Trent Geurts who is currently a POC with us and move Trent into the Paramedic Pilot Program for 2021. Currently Erica Kostichka is in this program but will be graduating in December.
