1. Granting Permission to Street Commissioner to Purchase Grader

Bob Piskula, Street Commisisoner, advised that they had a 2002 grader go down. He is looking to purchase a used one, however, when you find a used one, you need to act on it immediately as they do not last long.

Mr. Piskula noted that the grader and loader share a line item in the budget. He does not want to deplete the budget by purchasing a new grader. He feels a used one is most advantageous to the City. He is looking at graders with under 4,000 hours.

Upon inquiry by Aldersperson Darling, Mr. Piskula advised that the grader they looked at today was \$133,000 and the one they are looking at on Friday is \$145,000. A new grader is approximately \$250,000.

Upon inquiry by Aldersperson Balcerzak, Mr. Piskula advised that they put approximately 400-600 hours per year on the grader.

Upon inquiry by Aldersperson Turney, Mr. Piskula advised that he is weighing out his options in regard to the old grader.

Motion to grant permission to Street Commissioner to purchase used grader he deems most advantageous to the City of Antigo utilizing budgeted funds as presented.

Due to mechanical failure on a 2002 Volvo Grader, calls have been made checking on parts and we have been told that Volvo does not make graders any more. The cost of parts needed is more than this grader is worth.

I am requesting approval to be able to purchase a used grader for replacement without going out for bids utilizing existing money in CIP account. CIP- Grader or Loader Acct - 442.640.64001.57750. Bidding is not feasible as used inventory fluctuates.

I am also asking for permission to purchase a piece of equipment most advantageous to the City when a used grader is found as the timing of purchasing used equipment does not allow waiting for committee approval.
