Public notice is hereby given that the Planning Commission of the City of Antigo will hold a public hearing on October 10, 2018 beginning at 5:00 p.m. at City Hall, 700 Edison Street, Antigo, Wisconsin. The purpose of the public hearing is to:

1. Consider a proposed territory amendment for Tax Incremental Finance (TIF) District No. 7 for the City of Antigo. The proposed amendment would allow for the addition of parcels to TID #7, thereby changing its present boundary description.

Maps showing the boundaries of TID No. 7 and the associated Project Plan will be available upon request prior to the public hearing from the City Clerk, 700 Edison Street, Antigo, Wisconsin 54409, (715) 623-3633.

2. Consider a proposed allocation amendment for Tax Increment Finance District No. 6 for the City of Antigo. The proposed amendment would allow TID No. 6 to donate tax incremental finance funds toward costs incurred by projects undertaken in TID No. 3. The allocation would allow the use of TID No. 6 excess funds to be used for debt incurred by TID No. 3.

At the public hearing, interested parties will be given a reasonable opportunity to express their views on the proposed amendments.
