2. Tourism Promotion and Destination Agreement

Angie Close, Langlade County Economic Development Corporation (LCEDC), stated she has reviewed the agreement with the City of Antigo.

Mr. Haatvedt clarified that the effective dates of the agreement are January 1, 2026, through December 31, 2030.

Ms. Close questioned if the yearly audit LCEDC has performed by Kerber-Rose would satisfy the audit requirement in the agreement. Mr. Haatvedt stated if the audit lists out the money received from the Hotel Motel Room Tax separately LCEDC does not need to have a separate audit for the agreement.

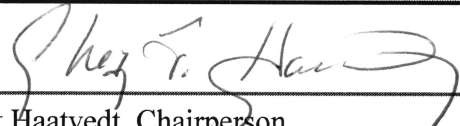
Any Other Matters Authorized by Law to be Considered

Upon inquiry by Thomas C. Bauknecht, Mayor, Kaye Matucheski, Clerk-Treasurer/Finance Director stated the remaining balance of the undesignated funds is \$34,926. Upon inquiry from Keri Beck, LCEDC, Ms. Matucheski stated so far for Hotel Motel Room Tax, the City has

collected \$122,037.15, noting the funding would be seventy percent of that total.
