RESOLUTION NO. 49-24

WHEREAS, bids were accepted for the hauling of biosolids (sludge) from the Wastewater Treatment Plant (WWTP) and two bids were received; and,

WHEREAS, Michael J. Waldvogel Trucking, LLC was the low bid of \$0.034 per gallon and staff recommends awarding Waldvogel the bid; and,

WHEREAS, the other bid was Kautza Septic Service, Inc at \$0.0369 and staff is recommending approval of Kautza as a back up hauler if ever needed.

NOW, THEREFORE, BE IT RESOLVED, BY THE COMMON COUNCIL, City of Antigo, to award Michael J. Waldvogel Trucking, LLC the bid for sludge hauling at a cost of \$0.034 per gallon.

BE IT FURTHER RESOLVED, in an emergency situation only, Kautza Septic Service, Inc. can be used as a back up.
